



Quest Summer Scholars: August 7 – 12, 2011

Residence Accommodation:

Students will be living in a shared bedroom with fellow students in our new condominium style residence. They will be accompanied by Quest's student ambassadors while living in residence and participating in the afternoon's course activities. While the residence is co-ed, students will be housed with students of the same gender.

Students will be required to comply with the University Residence Policies and Procedures. The University is a no-smoking facility and the use of alcohol and illegal drugs is not tolerated. Students in violation of University policies will be withdrawn from the program and the student will be asked to return to their city of residence by appropriate transportation and at their expense.

What to Bring:

What will you do?

You will be expected to arrive at the Quest campus in time for registration and dinner on Sunday evening at 6:00 p.m. Following dinner there will be an opportunity to meet your fellow students and have a brief overview of the week-long program and activities. You will have the evening to settle into residence and get ready for an early morning start to the week. The week-long course will end at 3:00 p.m. on Friday, August 12, 2011, and departure travel plans can be made accordingly.

Morning seminars throughout the week will be led by Prof. David J. Helfand, Chair of the Department of Astronomy at Columbia University in New York and a Visiting Tutor at Quest. The seminars will cover topics in astronomy, geology, radioactive dating, and genomics in exploring the forces that shaped the people of North America.

Afternoons will be led by Toran Savjord, Quest's Director of Recreation and Athletics and an experienced outdoor guide. The activities include a team-building game; a hike up to and around a glacier (approximately four hours and a minimum level of fitness is required); a nighttime astronomical observing session; a field-trip expedition ranging from the Squamish shoreline to a 2000-meter observation point to take measurements of cosmic radiation; a swim in a near-by lake (with life-jackets and supervised by an instructor with Red Cross Swimming Certification); and, an optional visit to a native sweat lodge.

You may wish to take a copy of your confirmed registration and course information to the relevant Visa authorities in your country to verify your participation in the Summer Scholars program.

INFORMED CONSENT AGREEMENT

I agree that the Board of Quest University Canada or its employees shall not be liable for any injury to the participant and/or loss or damage to my personal property arising from, or in any way resulting from, participation in these activities, unless such injury, loss or damage is caused by the sole negligence of the University or its employees or agents while acting within the scope of their duties.

In the event Quest University Canada determines, in its sole judgment and discretion, that disciplinary action is warranted against a Quest Summer Scholars participant, Quest University Canada may at any time prior to the end of the program return the participant to his/her city of residence by appropriate transportation. This could include a regular commercial airline of Quest University Canada's choice, in which case, I agree to indemnify and hold harmless Quest University Canada, its Board of Governors and employees, for all expenses of such return, including airfare.
